
Website Privacy Statement

Webroot Inc. (“we”, “us”, or “our”; such references also include Webroot’s affiliates and subsidiaries, as applicable) is committed to protecting and respecting your privacy.

This Website Privacy Statement (“**Statement**”) describes how we process and use personal information we collect from you when you visit and use our website. Information about our privacy practices with respect to the Webroot SecureAnywhere (WSA) products and services can be found [here](#). Other documents, including our [Terms of Use](#), our [Cookies Policy](#), and any other terms referenced on this website or in those policies or terms, describe Webroot’s personal information practices as such practices are described therein.

Please read the following carefully to understand our views and practices regarding your personal information and how we will treat it. By visiting any page on this website (“**our site**”), or taking any action on our site, you are accepting and consenting to the practices described in this Statement.

INFORMATION WE MAY COLLECT

We may collect and process the following information about you:

- **Personal Information you provide to us.** The types of personal information you give us may include: contact information such as your name, mailing address, email address, and phone number; as well as payment information, including credit card information and your billing address.
 - You may give us information about you by filling in forms on our site or by corresponding with us by phone, online chat, email, or otherwise. This includes, but is not limited to, information you provide when you register to use our site; log in to our site; search for a product; contact us about the site; place an order on our site; download any trial software or service; participate in discussion boards or other social media functions on our site; enter a competition, promotion or survey; and when you report a problem with our site. The information you give us may include your name, address, email address and phone number, and credit card information.
- **Other Information we may collect about you.** With regard to each of your visits to our website, we may automatically collect the following information:
 - technical information, including the internet protocol (IP) address used to connect your computer to the internet, your login information, browser and plug-in types and versions, and information about your operating system and operating platform; and

- information about your interaction with our website, such as the pages you visited on our website, products you viewed or searched for, the URLs from the websites you visit before and after navigating to our site, page response times, download errors, length of visits to certain pages, page interaction information (such as scrolling, clicks, and mouse-overs), and methods used to browse away from the page.
- **Information we receive from other sources.** We may receive information about you if you use any of the other websites we operate or the other services we provide. This information may be shared internally and combined with information collected on this site. We also work closely with third parties (including, for example, business partners; subcontractors in technical, payment and delivery services; advertising networks; analytics providers; search information providers; and credit reference agencies) and may receive information about you from them.

COOKIES AND DO NOT TRACK

Our site uses cookies to, among other things, operate, work more efficiently, and provide analytic information and advertising. For detailed information on the categories of cookies we use and the purposes for which we use them, see our [Cookies Policy](#). Please note that our websites may not recognize or take action in response to Do Not Track and similar signals from browsers.

HOW WE MAY USE YOUR INFORMATION

We may use information about you in the following ways:

- **Personal Information you may provide to us.** We may use this information:
 - to complete and fulfill your purchase, for example, to process your payments, communicate with you regarding your purchase, provide you with related customer service, and establish and manage your account;
 - to provide you with the information, products and services that you request from us;
 - to provide you with information about other software and services we offer that are similar to those that you have already purchased or inquired about;
 - to provide you, or permit selected third parties to provide you, with information about software or services we feel may interest you;
 - to communicate with you about our events, surveys, contests, sweepstakes, and other promotions (if you have not objected to receiving marketing communications);
 - to notify you about changes to our service and offerings and changes to our terms, conditions, and policies;
 - to ensure that content from our site is presented in an appropriate manner for you and for your computer, and is tailored to you;

- to provide technical support and other support services;
 - to enforce our legal rights or comply with applicable legal requirements, agreements, and policies; and
 - to perform other activities consistent with this Statement.
- **Other Information we may collect about you.** We and our service providers may use this information:
 - to administer our site and for internal operations, including troubleshooting, data analysis, testing, research, statistical, and survey purposes;
 - to improve our site to ensure that content is presented in an appropriate manner for you and for your computer, as well as to improve our products and service offerings;
 - to allow you to participate in interactive features of our service, when you choose to do so;
 - as part of our efforts to keep our site safe and secure;
 - to measure or understand the effectiveness of advertising served to you, and to deliver, or allow our service providers to deliver, relevant advertising to you, including interest-based advertising (otherwise known as “online behavioral advertising”); and
 - to make suggestions and recommendations to you and other users of our site about software or services that may interest you or them.
 - **Information we receive from other sources.** We may combine information we receive from third parties with personal information you give to us and other information we collect about you. We may use this information and the combined information for the purposes set out above (depending on the types of information we receive).

DISCLOSURE OF YOUR INFORMATION

We may share your personal information with our affiliates and subsidiaries. Such sharing will be for our reasonable business purposes, consistent with the types of uses for which we use your personal information as described in this Statement.

We may also share your personal information with other selected third parties, including:

- business partners, suppliers, and subcontractors, who have contractually agreed to keep your information secure and confidential and to use it only for the purpose for which it was supplied, for the performance of any contract we enter into with them or you;

- third-party customer support providers;
- advertisers, marketers, and advertising and marketing networks that use the information to select and serve relevant ads to you and others on our site, on other sites, and in apps, as permitted under applicable law and in accordance with your communication preferences; and
- analytics and search engine providers that assist us in the improvement and optimization of our site.

Finally, we may disclose your personal information:

- in the event that we or our affiliates or subsidiaries contemplate or enter into a reorganization, merger, sale, joint venture, assignment, transfer, or other disposition of all or any portion of our business or assets, in which case we or our affiliates or subsidiaries may disclose your personal information as part of that deal;
- if we have a good faith belief that we are under a duty to disclose or share your personal information in order to comply with applicable law or respond to valid legal process, including from law enforcement or other government agencies, or in order to enforce or apply our [Terms of Use](#), or the terms and conditions governing our products or services, or other agreements between us and you or between us and any third parties that relate to you; or to protect the rights, property, or safety of Webroot and our customers, our affiliates or subsidiaries, their customers, or other third parties. This includes exchanging information with other companies and organisations for the purposes of fraud and network protection.

PLEASE NOTE THAT ANY INFORMATION AND MATERIAL YOU POST OR DISCLOSE ON MESSAGE BOARDS, FORUMS, ONLINE CHAT PROGRAMS, PROFILE PAGES, AND BLOGS WILL BECOME PUBLIC INFORMATION AND MAY BE AVAILABLE TO USERS AND TO THE GENERAL PUBLIC. WE URGE YOU TO BE VERY CAREFUL WHEN DECIDING TO DISCLOSE YOUR PERSONAL INFORMATION, OR ANY OTHER INFORMATION, ONLINE.

WHERE WE PROCESS YOUR PERSONAL INFORMATION

The information which we collect from you may be transferred to, processed at, and stored in the USA or any location where our subsidiaries, affiliates, or service providers maintain facilities. By submitting your personal information, you hereby consent and agree to this transfer, storing, or processing.

We will take those steps reasonably necessary to ensure that your information is treated securely and in accordance with this Statement and the requirements of applicable law wherever the information is located. In order to safeguard your personal information in countries outside the

European Economic Area (EEA), we have implemented appropriate physical, technical, and organizational measures to ensure a level of security appropriate to the risks. In addition, we have put in place in agreements between us and our affiliates or subsidiaries in the EEA containing standard data protection clauses which have been adopted by the European Commission.

YOUR ACKNOWLEDGMENTS

RETENTION OF PERSONAL INFORMATION

We retain your personal information:

- for as long as is necessary for the purpose for which we collect it.

After your service has expired or terminated, we may delete your name, email address, and transactional data (e.g., license key), so that we limit our ability to reasonably identify you.

PROVISIONS APPLICABLE TO CALIFORNIA RESIDENTS ONLY
